## CALL FOR WRITTEN SUBMISSIONS – JUNE 2, 2009

### PARLIAMENTARY PANEL TO HOLD INQUIRY INTO ANTISEMITISM IN CANADA

**Scott Reid, MP** Chair of the CPCCA Steering Committee and **Mario Silva, MP** Chair of the CPCCA Inquiry Panel announced a parliamentary inquiry into Antisemitism in Canada **on June 2, 2009**. The inquiry will consider evidence on the nature of contemporary Antisemitism, evaluate current efforts to confront it, and consider further measures that might usefully be introduced. The inquiry is seeking **written submissions of no more than 2,000 words** from interested parties, before taking oral evidence. Organizations and individuals wishing to make written submissions are invited to do so before **October 1<sup>st</sup>, 2009**.

Each submission should include the name and postal address of the individual or organization and state whether it has been prepared specifically for the inquiry. Where submitted by an organization rather than an individual, the submission should briefly explain the nature and membership of the organization. Oral evidence will be taken in Parliament, beginning in the fall of 2009. A report is expected to be published in the spring and presented to the Parliament of Canada.
